may be liable for by reason of negligence of said Principal in the construction of said work and shall do all things required
to be done and performed under said Contract, including the maintenance of subject property for a period of two (2) years
from the date of acceptance by said City, then this obligation shall be null and void; otherwise to be in full force and
effect.

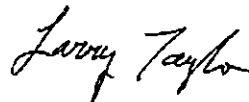

It is fully understood that consenting to the State of Florida Department of Transportation making payment of the final estimate to the Contractor and/or its assignee, shall not relieve this surety company of any of its obligations under its bond.

In connection with obligations in favor of the Kentucky Department of Highways only, it is agreed that the power and authority hereby given to the Attorney-in-Fact cannot be modified or revoked unless prior written personal notice of such intent has been given to the Commissioner - Department of Highways of the Commonwealth of Kentucky at least thirty (30) days prior to the modification or revocation.

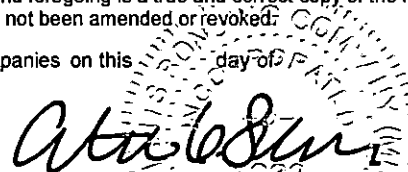
