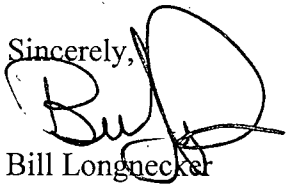

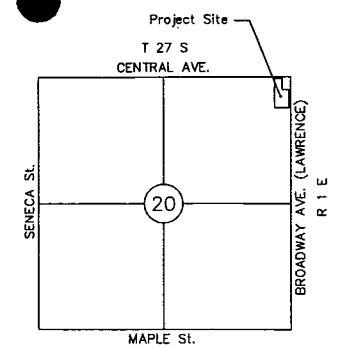

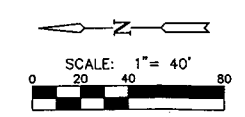

VICINITY MAP

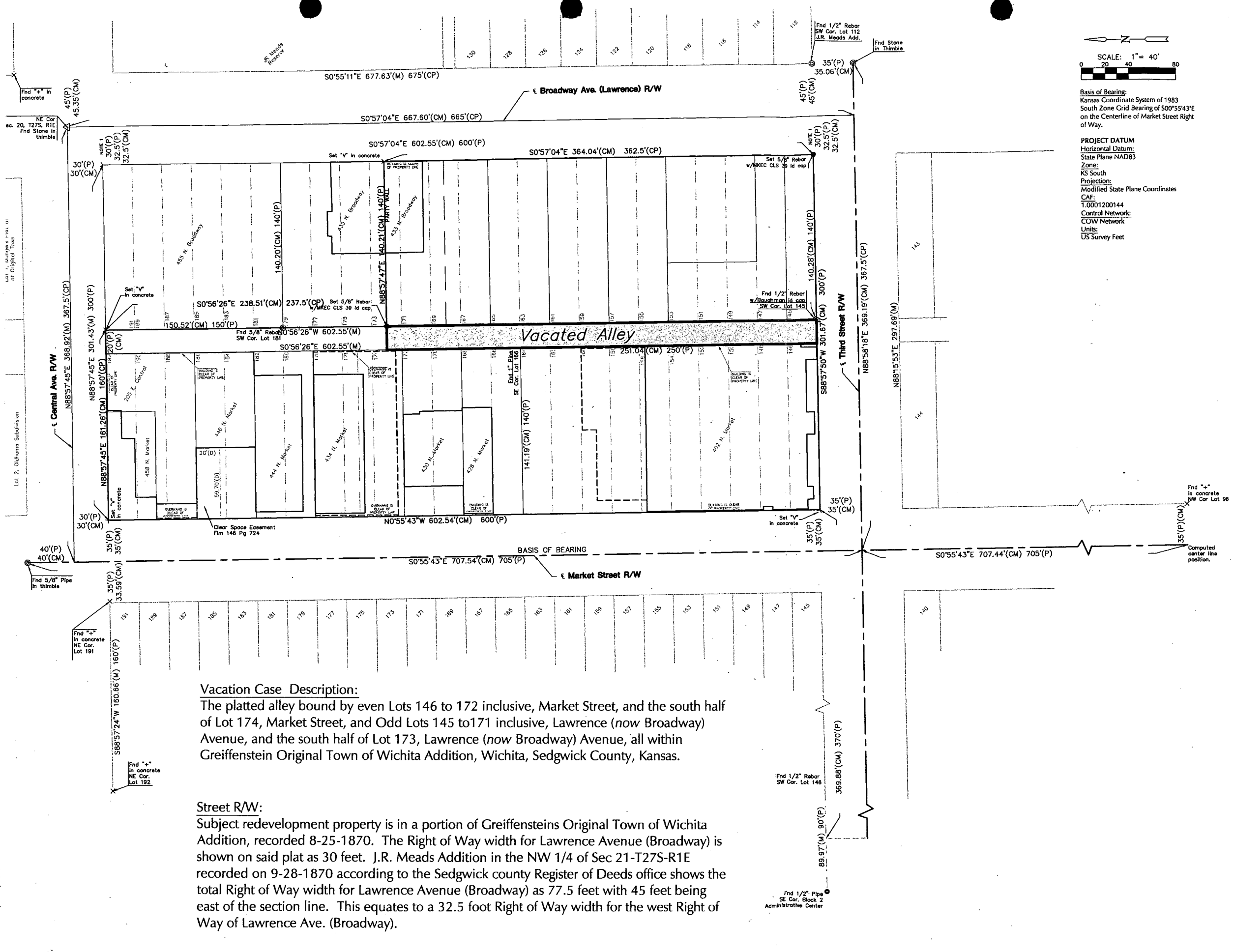

Vacation Case Description:
The platted alley bound by even Lots 146 to 172 inclusive, Market Street, and the south half of Lot 174, Market Street, and Odd Lots 145 to 171 inclusive, Lawrence (now Broadway) Avenue, and the south half of Lot 173, Lawrence (now Broadway) Avenue, all within Greiffenstein Original Town of Wichita Addition, Wichita, Sedgwick County, Kansas.

Street R/W:
Subject redevelopment property is in a portion of Greiffensteins Original Town of Wichita Addition, recorded 8-25-1870. The Right of Way width for Lawrence Avenue (Broadway) is shown on said plat as 30 feet. J.R. Meads Addition in the NW 1/4 of Sec 21-T27S-R1E recorded on 9-28-1870 according to the Sedgwick county Register of Deeds office shows the total Right of Way width for Lawrence Avenue (Broadway) as 77.5 feet with 45 feet being east of the section line. This equates to a 32.5 foot Right of Way width for the west Right of Way of Lawrence Ave. (Broadway).
