AN ORDINANCE CHANGING THE ZONING CLASSIFICATIONS OR DISTRICTS OF CERTAIN LANDS LOCATED IN THE CITY OF WICHITA, KANSAS, UNDER THE AUTHORITY GRANTED BY THE WICHITA-SEDGWICK COUNTY UNIFIED ZONING CODE, SECTION V-C, AS ADOPTED BY SECTION 28.04.010, AS AMENDED.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS.

SECTION 1. That having received a recommendation from the Planning Commission, and proper notice having been given and hearing held as provided by law and under authority and subject to the provisions of The Wichita-Sedgwick County Unified Zoning Code, Section V-C, as adopted by Section 28.04.010, as amended, the zoning classification or districts of the lands legally described hereby are changed as follows:

Case No. ZON2021-00022

City zone change from MF-29 Family-Residential and GO General Office to NR Neighborhood Retail zoning described as:

Lot 3, EXCEPT the West 20 feet for street, Hillside Avenue, Floral Addition, Wichita, Sedgwick County, Kansas. AND Lot 5, on Hillside Avenue, in Floral Addition to Wichita, Sedgwick County, Kansas.

Subject to Protective Overlay #375 as follows:

1. The site shall be restricted to the uses permitted by-right in NR Neighborhood Retail District, except the following uses shall be prohibited: Restaurant and Cash Advance/Title Loan or similar type lending business.

SECTION 2. That upon the taking effect of this ordinance, the above zoning changes shall be entered and shown on the "Official Zoning Map" previously adopted by reference, and said official zoning map is hereby reincorporated as a part of the Wichita -Sedgwick County Unified Zoning Code as amended.

SECTION 3. That this Ordinance shall take effect and be in force from and after its adoption and publication in the official City paper.

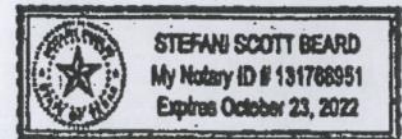
