2. A site plan illustrating the area of outdoor storage and required screening shall be submitted to the Planning Department for review and approval within 90 days of approval of the zone change.

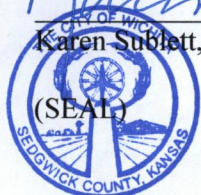
