At its regular meeting held on August 7, 1958, the Metropolitan Area Planning Commission considered the above dedication, being more specifically described as beginning at the intersection of the center line of 15th Street and the east line of Second Westborough Place, thence east along the center line of 15th Street a distance of 199 feet, thence southerly with an angle to the right of 117 degrees, 51 minutes, 30 seconds, to a point 30 feet south of the center line of 15th Street, thence west to the northeast corner of Lot 12, Block 4, Second Westborough Place, thence northerly to the point of beginning.

It was moved, seconded and carried unani-  
mously that the Planning Commission recommend  
to the City Commission that this dedication  
be approved.
