At the regular meeting of the Metropolitan Area Planning Commission held on August 20, 1959, the above dedications were considered. These dedications are more specifically described as follows:

D-0137 - Dedication from William S. and Madeline C. Brenner for the north 10 feet of the south 30 feet of a tract beginning 660 feet north and 429 feet west of the southeast corner of the SE $\frac{1}{4}$ of Section 31, Township 27 South, Range 1 East; thence north 165 feet; thence west 132 feet; thence south 165 feet; thence east to point of beginning.

D-0138 - Dedication from Robert G. and Neva B. Widener for north 10 feet of the south 30 feet of a tract described as the east 165 feet of a tract beginning 40 rods north and 58 rods west of the southeast corner of the SE $\frac{1}{4}$ of Section 31, Township 27 South, Range 1 East; thence west 14 rods; thence north 20 rods; thence east 14 rods; thence south 20 rods to point of beginning.

D-0142 - Dedication from Leon F. and Lois M. Brown and Rolling Hills Mesa, Inc. for the north 10 feet of the south 30 feet of a tract beginning 660 feet north and 1320 feet west of the southeast corner of the SE $\frac{1}{4}$ of Section 31, Township 27 South, Range 1 East, thence north 160 feet; thence east 75 feet; thence south 160 feet; thence west to point of beginning.

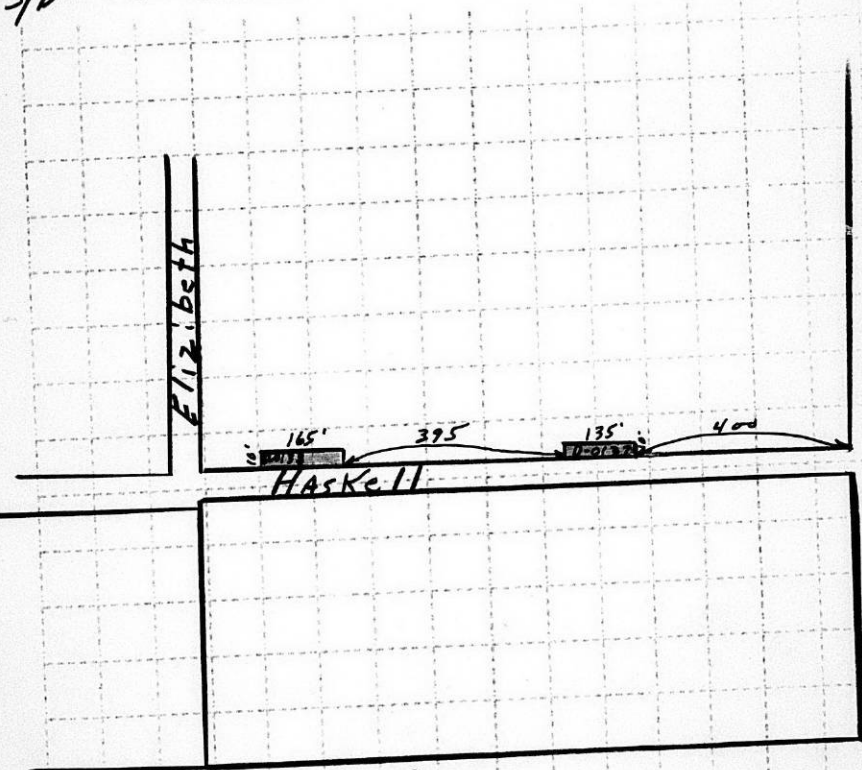
It was moved, seconded and carried unanimously that the Planning Commission recommend to the Board of City Commissioners that the above dedications be approved.
