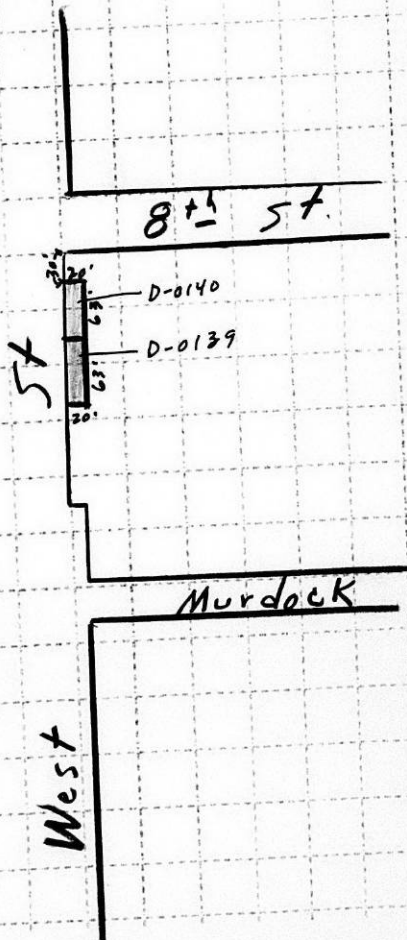

At the regular meeting of the Metropolitan Area Planning Commission held on August 20, 1959, the above dedications were considered. These dedications are more specifically described as follows:

D-0139 - Dedication from Mrs. C.J. and J.B. Wilson for the west 20 feet of a tract beginning 1892 feet north and 30 feet east of the southwest corner of the SW $\frac{1}{4}$ of Section 13, Township 27 South, Range 1 West; thence east 258 feet; thence south 63 feet; thence west 258 feet; thence north 63 feet to the point of beginning.

D-0140 - Dedication from Mrs. C.J. and J.B. Wilson for the west 20 feet of a tract beginning at a point 1955 feet north and 30 feet east of the southwest corner of the SW $\frac{1}{4}$ of Section 13, Township 27 South, Range 1 West; thence east 258 feet; thence south 63 feet; thence west 258 feet; thence north 63 feet to point of beginning.

D-0141 - Dedication from Mike and Louise Savute for the west 20 feet of a tract beginning 1063 $\frac{1}{3}$ feet north and 30 feet east of the southwest corner of the SW $\frac{1}{4}$ of Section 13, Township 27 South, Range 1 West; thence north 242 feet; thence east 372 feet; thence south 242 feet; thence west to point of beginning.

D-0144 - Dedication from Wayne E. and Norma Jean McKay for the west 10 feet of Lot 8, Block 4, Golden Gardens Addition.

D-0145 - Dedication from Wayne E. and Norma Jean McKay for the west 10 feet of Lot 19, Block 5, Golden Gardens Addition.
