The frontage road south of Kellogg between Poplar and Chataqua be named Kellogg Drive.

The frontage road south of Kellogg between Rutan and Yale be named Kellogg Drive.

The frontage road north of Kellogg between Pattie and Hydraulic be named Kellogg Drive.

The frontage road north of Kellogg between Poplar and Lorraine be named Kellogg Drive.

The frontage road north of Kellogg between Holyoke and Yale be named Kellogg Drive.

To Whom It May Concern:

This is to advise you that the Department of Public Works has requested that street names be established for certain streets in connection with the Kellogg reconstruction in an area from Pattie Street to Yale. The streets and the requested street names are:

- 1) South side of Kellogg - a new frontage road being constructed from Pattie to Kansas; from Poplar to Chautauqua; and from Rutan to Yale, to be named Kellogg Drive.
- 2) North side of Kellogg - a new frontage road being constructed from Pattie to Hydraulic; from Poplar to Lorraine; and from Holyoke to Yale, to be named Kellogg Drive.
- 3) Lewis Street from Hydraulic east to the cul-de-sac, to be Lewis Circle.
- 4) Giltner from Hydraulic east to the cul-de-sac, to be Giltner Circle.

You should also note that the afore described streets, with the exception of Lewis and Giltner, are all to be constructed on the existing Kellogg Street right-of-way.
