RE: BZA2025-00020: Administrative Adjustment in the City to revise an approved site plan for BZA2024-00002 to permit construction of a screening wall up to 10 feet in height at additional locations on the subject site, on property zoned SF-5 Single-Family Residential District, generally located on the west side of North Hoover Street and within one-half mile south of West Central Avenue (255 N. Hoover Street).

Dear applicant,

We reviewed your Administrative Adjustment request to revise an approved site plan for BZA2024-00002 on a property zoned SF-5 Single-Family Residential District (SF-5) to permit construction of a screening wall up to 10 feet in height at additional locations around the subject site to further screen the existing and proposed expansion of an electrical substation.

On February 22, 2024, the Board of Zoning Appeals approved BZA2024-00002 to permit construction of a screening wall, within the building setbacks, that exceeds the maximum height of 8 feet as restricted by Section III-E.1.e.(1).(b). The approved site plan illustrates a screening wall along the south property line and along the east property line. The proposed revised site plan illustrates an additional location for the screening wall along the west property line.

We find that the adjustment to the site plan as proposed meets the four conditions required by Section V-I.6 of the Unified Zoning Code as set out below:

- 1) **Impact on safety and convenience of vehicular and pedestrian circulation:** The proposed Administrative Adjustment to BZA2024-00002 should have no impact on the safety and convenience of vehicular traffic and pedestrian circulation in the vicinity of the application area. The additional location of the screening wall is not within the right-of-way and will not have any visual impact to drivers along I-235.

- 2) Impact on existing uses in surrounding areas: The original Variance application discussed the ability for a screening wall of up to 10 feet in height to be constructed within the setbacks for the entire subject area. It is only the approved site plan that identified the original location of the screening wall to be on the east and south sides only. The addition of the wall on the west side will further screen the view of the substation expansion and will not likely have significant negative impact on surrounding uses.
- 3) Compatibility with existing or permitted uses on abutting sites: The original Variance application discussed the ability for a screening wall of up to 10 feet in height to be constructed within the setbacks for the entire subject area. It is only the approved site plan that identified the original location of the screening wall to be on the east and south sides only. The addition of the wall on the west side will further screen the view of the substation expansion and will not likely have significant negative impact on surrounding uses.
- 4) Effect on public health, safety, or welfare: It is not anticipated to have any significant negative impacts on the public health, safety, or welfare, nor will properties or improvements in the vicinity be materially injured.

Our signatures below indicate that the Administrative Adjustment to revise the approved site plan for BZA2024-00002 to permit construction of a screening wall up to 10 feet in height at additional locations of the subject site is hereby GRANTED, subject to the following conditions:

1. All original conditions of BZA2024-00002 shall be adhered to.
2. The site shall be developed in general conformance with the approved, revised site plan submitted with this application.
3. If the Zoning Administrator finds that there is a violation of any of the conditions of the Zoning Adjustment, the Zoning Administrator, in addition to enforcing the other remedies set forth in the Unified Zoning Code, may, with the concurrence of the Planning Director, declare that the Zoning Adjustment is null and void.

The "Development Application" sign should now be removed from the property.
