REQUEST FOR ZONING

SCZ-0529 - ZONE CHANGE FROM THE "R-1" SUBURBAN RESIDENTIAL
TO THE "C" COMMERCIAL DISTRICT. GENERALLY LOCATED ON THE
SOUTH SIDE OF 31ST STREET SOUTH IN AN AREA APPROXIMATELY
1/4 MILE OF WEBB ROAD.
