REQUEST FOR ZONING

SCZ-0609 - ZONE CHANGE FROM THE "LC" LIGHT COMMERCIAL DISTRICT TO THE
"R-1" SUBURBAN RESIDENTIAL DISTRICT, LOCATED ON THE WEST SIDE OF
WOODLAWN IN AN AREA SOUTH OF 49TH STREET SOUTH, IF EXTENDED FROM THE
EAST.

A RESOLUTION CHANGING THE ZONING CLASSIFICATIONS, FOR CERTAIN LANDS LOCATED WITHIN THE UNINCORPORATED AREA OF SEDGWICK COUNTY, KANSAS, UNDER THE AUTHORITY GRANTED IN SECTION 17.C OF THE ZONING REGULATIONS ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, DECEMBER 12, 1984, AND SUBSEQUENTLY AMENDED.

BE IT RESOLVED BY THE GOVERNING BODY OF SEDGWICK COUNTY, KANSAS.

SECTION I. That after receiving a recommendation from the Wichita-Sedgwick County Metropolitan Area Planning Commission, and after said Planning Commission has given proper notice and held a public hearing as provided by law, and under authority granted by Section 17.C of the Zoning Regulations, the zoning districts of the lands legally described below are hereby changed as follows:

CASE NO. SCZ-0609
Zone Change from the "LC" Light
Commercial District
to the "R-1" Suburban Residential
District

The South 600 feet of the East 600 feet
of the Northeast Quarter of Section 24,
Township 28 South, Range 1 East of the
Sixth P.M., Sedgwick County, Kansas.
Generally located on the west side of
Woodlawn in an area south of 49th Street
South, if extended from the East.

SECTION II. That upon the taking effect of this Resolution, the notation of such zone change shall be entered in the official zoning atlas on file in the Office of the County Zoning Administrator and in the Office of the Wichita-Sedgwick County Metropolitan Area Planning Department.

SECTION III. That this Resolution shall take effect and be in force from and after its adoption and publication in the official county paper.

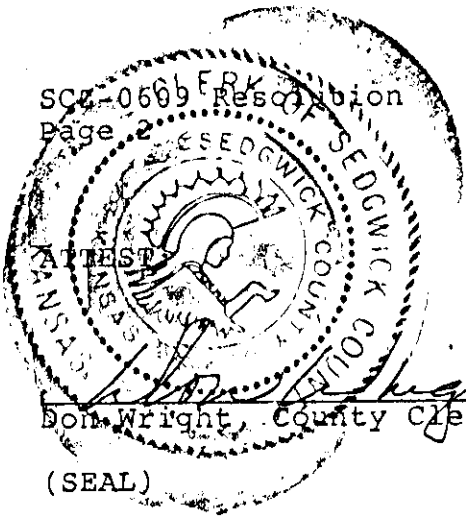
