ORDINANCE NO. 38-298

AN ORDINANCE VACATING THE FIVE-FOOT UTILITY EASEMENT ON THE NORTH SIDE OF LOT 3, BLOCK A, PATE AND VESTERING REPLAT OF PART OF STEWART'S SUBDIVISION, SEDGWICK COUNTY, KANSAS, EXCEPT THE EAST TEN FEET THEREOF.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the utility easement described as follows to-wit:

The five-foot utility easement on the north side of Lot 3, Block A, Pate and Vestering Replat of Part of Stewart's Subdivision, Sedgwick County, Kansas, except the east ten feet thereof; (MAPC NO. V-1171);

be and the same is hereby vacated in accordance with K.S.A. 13-443, subject, however, to the concurrence in such vacation by the Board of County Commissioners as by law provided.

SECTION 2. That it is hereby recommended to the Board of County Commissioners of Sedgwick County, Kansas, that said above described easement be vacated by said Board in case a proper petition is filed under the provisions of K.S.A. 12-504, 12-505 and K.S.A. 12-506.

SECTION 3. That this Ordinance shall be in force and take effect from and after its passage and publication once in the official city paper.
