SUBJECT: V-1493 - REQUEST TO VACATE A PORTION OF A PLATTED
UTILITY EASEMENT.

INITIATED BY: Metropolitan Area Planning Department

AGENDA ACTION: Planning

Staff Recommendation: Approve vacation of utility easement.

MAPC Recommendation: Approve vacation of utility easement. (unanimous)

Location: On the west side of Shefford, in an area north of First Street.
(District #5).

Applicant: Shade Investment Company, 9001 W. Central, Wichita, KS 67212

Site Size: A 20-foot wide portion of a 30-foot utility easement measuring 130 feet in length.

Current Zoning: "AA" (Single-Family)

Background: This vacation case has been requested to gain more buildable lot. The Utility Advisory Committee has verified that the portion of easement recommended for vacation is in excess of their utility easement needed. Sanitary sewer was constructed in an easement on the lots to the north, rather than in this easement as anticipated at the time of platting. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Action: Close public hearing; approve vacation; authorize the Mayor to sign the Vacation Order; and record certified copy of Order, recording costs to be billed to:

4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.
5. The vacation of the utility easement described herein should be approved.
