SUBJECT: V-1480 - REQUEST TO VACATE COMPLETE ACCESS CONTROL TO 47TH STREET SOUTH.

INITIATED BY: Metropolitan Area Planning Department

Staff Recommendation: Approve vacation of access control.

MAPC Recommendation: Approve vacation of access control. (unanimous)

Location: On the south side of 47th Street South, west of Laura. (District #4).

Applicant: I-135 Business Park, Inc., 409 N. Maize Road, Wichita, KS 67212

Site Size: The subject lot contains approximately 32,550 square feet.

Current Zoning: "E" (Light Industrial)

Background: Several years ago this applicant granted "complete access control" to 47th Street in order to avoid paying special assessments for that street's paving. Now, the applicant is planning on selling the property to Derby Refining Company for development of a service station. Derby desires to have an access point to 47th Street. This vacation case has been requested so the subject lot can regain its original one access point to 47th Street. The new owner of the property has acknowledged the fact that they should now be included within the benefit district to help pay for the adjacent street improvements. The Planning Commission established this acknowledgment as a condition of approval. Also, the Vacation Order retains "access control except for one opening". The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Action: Close public hearing; approve vacation; instruct City Clerk to place 47th Street South paving assessment on subject property; authorize the Mayor to sign the Vacation Order; and record certified copy of Order, recording costs to be billed to:

5. "Access control except for one opening" is hereby retained.
6. The vacation of the access control described herein should be approved.
