SUBJECT: V-1476 - REQUEST TO VACATE A PORTION OF A PLATTED UTILITY
EASEMENT.

INITIATED BY: Metropolitan Area Planning Department

AGENDA ACTION: Planning

Staff Recommendation: Approve vacation of utility easement.

MAPC Recommendation: Approve vacation of utility easement. (unanimous)

Location: In an area west of Yale and south of Kellogg. (District #3).

Applicant: Lawrence D. Montgomery, 531 S. Yale, Wichita, KS 67218

Site Size: A 5-foot wide portion of a utility easement measuring 100 feet in length.

Current Zoning: "AA" (Single-family)

Background: This vacation case has been requested in order to provide additional buildable lot area for a detached garage. The Utility Advisory Committee has verified that the portion of utility easement being vacated is not needed for public utilities. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Action: Close public hearing; approve vacation; authorize the Mayor to sign the Vacation Order; and record certified copy of Order, recording costs to be billed to:

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

1. That due and legal notice has been given by publication as required by law, by publication in the Daily Record of notice of this vacation proceeding for consecutive weeks on AUGUST 19 & 26, 1987.
2. No private rights will be injured or endangered by the vacation of the above-described utility easement, and the public will suffer no loss or inconvenience thereby.
3. In justice to the petitioner(s) the prayer of the petition ought to be granted.
4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.
5. The vacation of the utility easement described herein should be approved.
