Staff Recommendation: Approve vacation of a utility easement.

MAPC Recommendation: Approve vacation of a utility easement. (unanimous)

Background: The applicant wishes to use the area being vacated for expansion of an existing structure. City Engineering and the Utility Advisory Committee have indicated that no adverse effects should result from this vacation. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

The part of Lot 5, Block 2, Second Addition To Vickridge, Sedgwick County, Kansas, described as commencing at the N.E. Corner thereof; thence west along the north line of said Lot 5, 9 feet; thence south at right angles to the last described line, 16 feet for a place of beginning; thence west parallel with the north line of said Lot 5, 69 feet; thence north at right angles to the last described line, 2.1 feet; thence east parallel with the north line of Lot 5, 69 feet; thence south, 2.1 feet to the place of beginning.

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

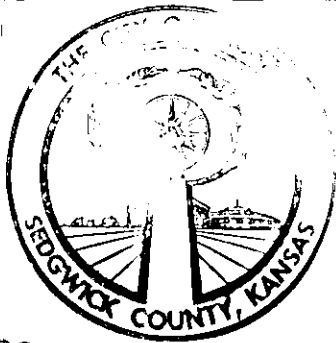
1. That due and legal notice has been given by publication as required by law, by publication in the Daily Record of notice of this vacation proceeding for consecutive weeks on .
2. No private rights will be injured or endangered by the vacation of the above-described portion of utility easement, and the public will suffer no loss or inconvenience thereby.
3. In justice to the petitioner(s), the prayer of the petition ought to be granted.
4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.
5. The vacation of the portion of utility easement described herein should be approved.
