SUBJECT: PUBLIC HEARING V-1583 - REQUEST TO VACATE STREET RIGHT-OF-WAY FOR SIERRA DRIVE LOCATED IN AN AREA SOUTH OF IRVING STREET.
(District #5)

INITIATED BY: Metropolitan Area Planning Department

AGENDA ACTION: Planning

Staff Recommendation: Approve vacation of street right-of-way.

MAPC Recommendation: Approve vacation of street right-of-way. (unanimous)

Background: This section of Sierra Drive is presently unimproved and terminates in a dead end at its south end due to the presence of railroad tracks. By vacating this street, a car rental facility at this site, will be able to provide direct access to Airport Road for rental customers. City Engineering has indicated that this right-of-way is no longer needed and the Airport Authority has also agreed to the vacation and opening in access to Airport Road. The Utility advisory Committee has also indicated that no adverse effects should result from the vacation. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Action: Close public hearing, approve vacation; authorize the Mayor to sign the Vacation Order; and record certified copy of Order, recording costs to be billed to:

2. No private rights will be injured or endangered by the vacation of the above-described street right-of-way, and the public will suffer no loss or inconvenience thereby.

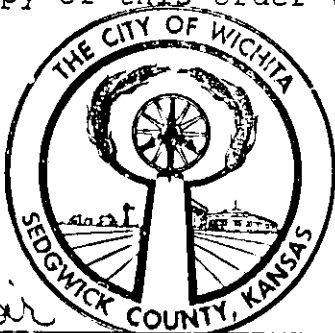
3. In justice to the petitioner(s), the prayer of the petition ought to be granted.

6. The vacation of the street right-of-way described herein should be approved.

IT IS, THEREFORE, BY THE CITY COUNCIL, on this 14th day of February, 1989, ordered that the above-described street right-of-way is hereby vacated. IT IS FURTHER ORDERED that the City Clerk shall certify a copy of this order to the Register of Deeds of Sedgwick County.
