SUBJECT: V-1560 - Request to vacate a portion of floodway reserve located east of 135th S. West and north of Forrest View.

INITIATED BY: Metropolitan Area Planning Department

AGENDA ACTION: Planning

Staff Recommendation: Approve vacation of floodway reserve.

MAPC Recommendation: Approve vacation of floodway reserve.
(unanimous)

Background: A portion of a house and deck of the property owner submitting the vacation request has been found to encroach a floodway reserve. County Engineering has reviewed the vacation and indicates that no detrimental impacts will result by the area involved being vacated. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: This request for vacation is located on property outside the City of Wichita, but within three miles thereof. As such, no petition, publication of notification or public hearing is required before the Wichita City Council.

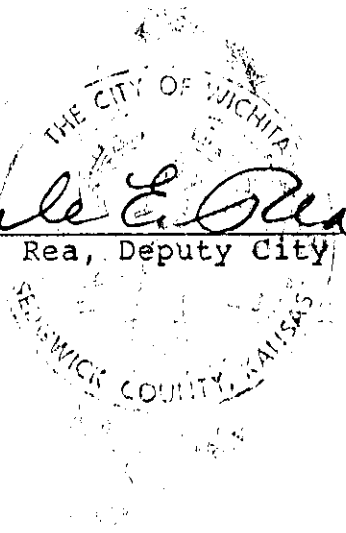
SECTION 3. That this resolution shall be in force and take effect from and after its passage and publication once in the official city paper.
