Staff Recommendation: Approve vacation of drainage and sewer
easement.

Background: The applicant has leased this property from the City of
Wichita, and requires this vacation to allow the placement of footings
for a building expansion. City Engineering has verified that this
request will not adversely affect existing storm or sanitary sewer
systems in the area. The vacation request has been reviewed and
approved by the Planning Commission, subject to conditions.

4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.
5. The vacation of the drainage and sewer easement described herein should be approved.
