Staff Recommendation: Approve vacation of access control.

Background: This site was platted in 1977 with 2 access openings. The applicant plans to sell off the southern portion of the lot and the buyer would like an additional opening. The vacation will vacate access control along the east line, however, the vacation order will retain access control except for three openings. As a condition of this vacation, the applicant is guaranteeing the extension of a decel lane adjacent to the east line of this property by petition. City Engineering and the utility companies have indicated approval of this vacation. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Action: Close public hearing, approve the decel petition and vacation and adopt the resolution; authorize the Mayor to sign the petition and Vacation Order; and record certified copy of Order, recording costs to be billed to:

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:



6. The vacation of the access control described herein should be approved.




