SUBJECT: PUBLIC HEARING V-1714 - REQUEST TO VACATE AN AREA OF PLATTED
COMPLETE ACCESS CONTROL
(District #4)

INITIATED BY: Metropolitan Area Planning Department

AGENDA ACTION: Planning

Staff Recommendation: Approve vacation of complete access control.

MAPC Recommendation: Approve vacation of complete access control.
(unanimous)

Background: The applicant is requesting an opening to Gold Street in order to alleviate traffic congestion to the south along MacArthur, which has two access openings. The City agreed to allow the vacation of an area of complete access control with the vacation order retaining "access control except for one opening for the north 300 feet." In return the applicant has submitted a contingent dedication which rededicates the access control being vacated by this case. The contingent dedication is subject to the City improving Mclean Boulevard and installing a turn lane from the south and a decel lane from the north. City Engineering and the utility companies have indicated their approval of this vacation. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Action: Close public hearing, approve vacation, accept the dedication; authorize the Mayor to sign the Vacation Order; record certified copy of Order and dedication recording costs to be billed to:

2. No private rights will be injured or endangered by the vacation of the above-described platted access control, and the public will suffer no loss or inconvenience thereby.
3. In justice to the petitioner(s), the prayer of the petition ought to be granted.
4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.
5. Access control except for one opening shall be retained for the north 300 feet.
6. The vacation of the platted access control described herein should be approved.
