Staff Recommendation: Approve vacation of platted complete access control.

MAPC Recommendation: Approve vacation of platted complete access control. (unanimous)

Background: The applicant is requesting to vacate a portion of platted complete access control to Killarney Place Fourth Addition which was platted in 1990. The associated Community Unit Plan provided only one opening to Rock Road for this addition and when platted the lot to the north received the opening with access to Lot 3 being provided by 32nd St. North. The vacation order does retain access control except for one opening for the area being vacated. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Action: Close public hearing, approve vacation; authorize the Mayor to sign the Vacation Order; and record certified copy of Order, recording costs to be billed to:

5. Access control except for one opening for the north 61.49 feet shall be retained.
6. The vacation of the platted complete access control described herein should be approved.

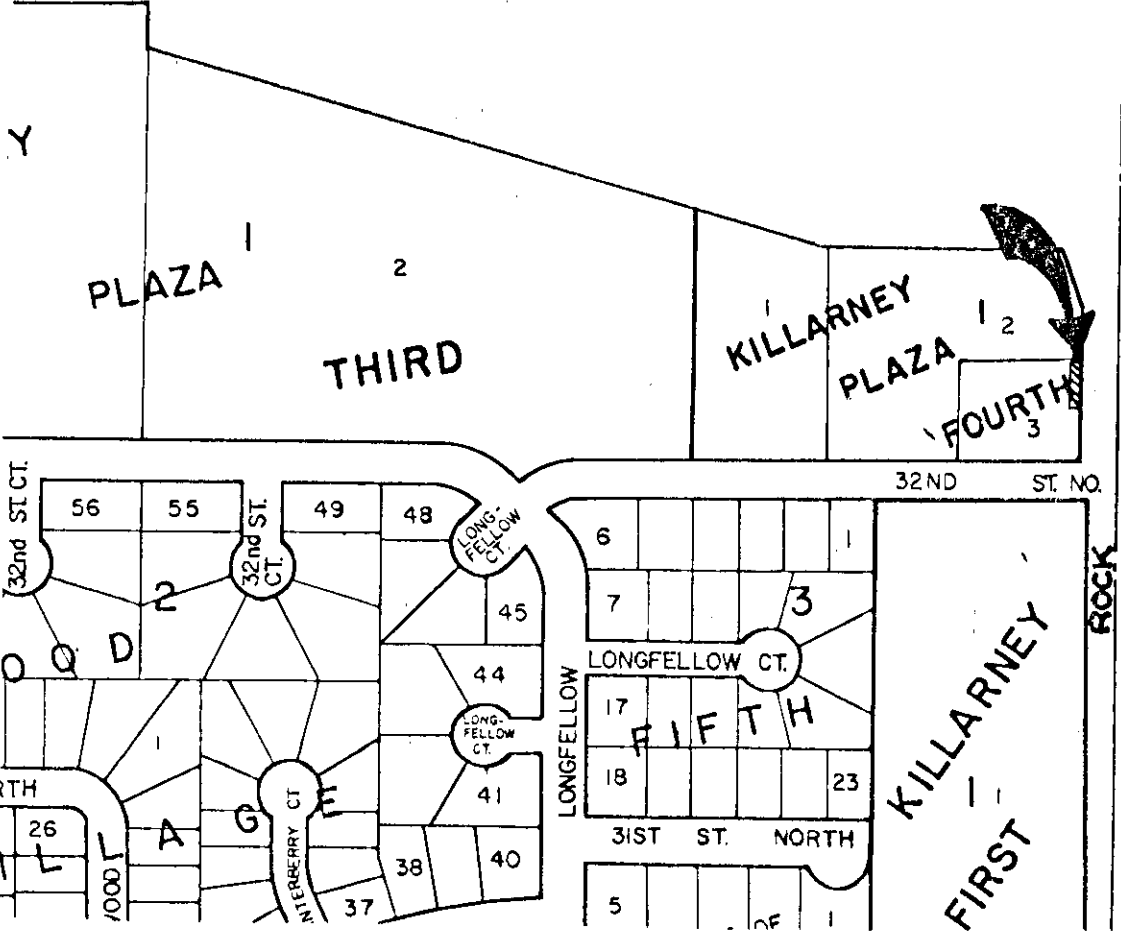
