Staff Recommendation: Approve vacation of platted utility easement.

MAPC Recommendation: Approve vacation of platted utility easement.

Background: The applicant seeks to vacate a portion of a platted utility easement in order to construct a concrete wall. A substitute easement has been submitted for this site. The utility companies and City Engineering have indicated their approval of this vacation. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Action: Close public hearing, accept dedication; approve vacation; authorize the Mayor to sign the Vacation Order; and record certified copy of Order and Dedication, recording costs to be billed to:

5. The vacation of the utility easement described herein should be approved.

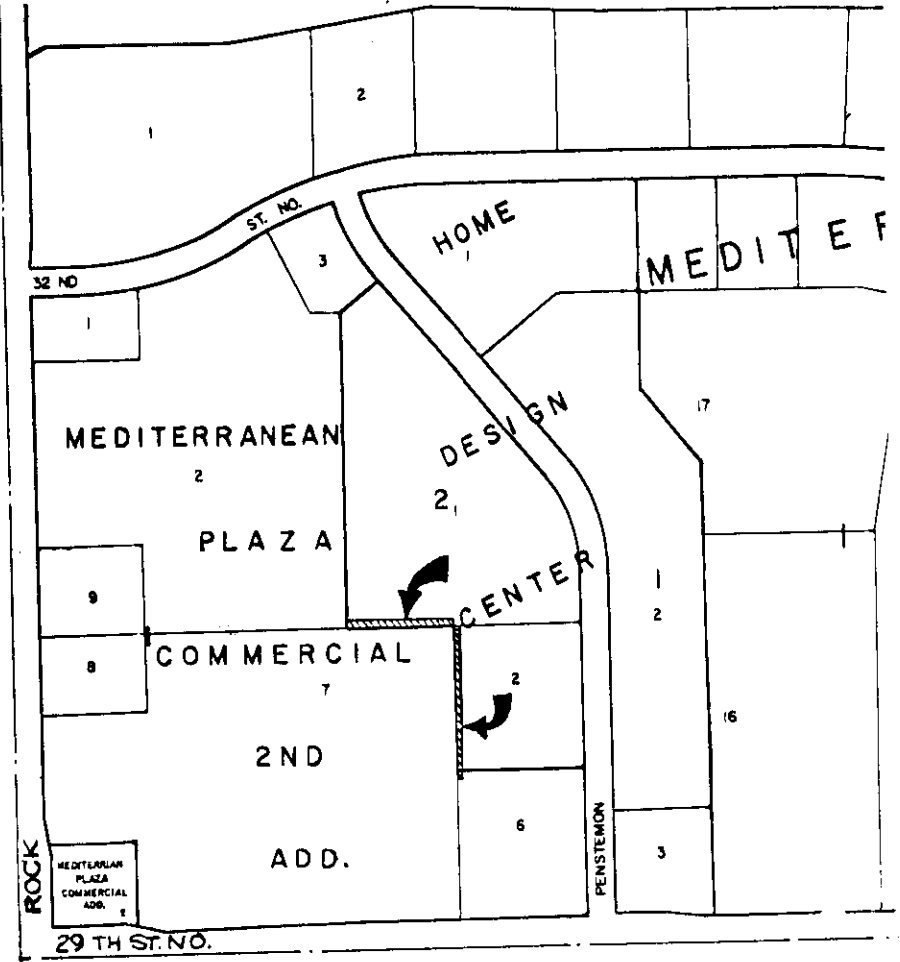
