SUBJECT: PUBLIC HEARING V-1679 - REQUEST TO VACATE A PORTION OF 29TH STREET NORTH; LOCATED NORTHEAST OF WEBB ROAD AND SOUTH OF COLONEL JAMES JABARA AIRPORT
(District #2)

Staff Recommendation: Approve vacation of a portion of a street.

MAPC Recommendation: Approve vacation of a portion of a street.
(unanimous)

Background: A request by the Wichita Airport Authority to vacate the City's half-mile portion of 29th Street North is being submitted in conjunction with the request to vacate the County's half mile portion. The applicant is requesting the vacation in order to allow for the construction of the K-96 freeway at Webb and to provide an obstacle free zone. The K-96 Freeway - Webb Road interchange does not include 29th Street in its design and the Airport Authority owns the land adjacent to both sides of the street. The City Engineer and Utility Companies have indicated their approval of this vacation. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Action: Close public hearing, approve vacation; authorize the Mayor to sign the Vacation Order; and record certified copy of Order, recording costs to be billed to:
