VACATION ORDER

NOW on this 9th day of October, 1990, comes on for hearing the petition for vacation filed by Todd E. Parker, praying for the vacation of the following described platted building setback, to-wit:

That portion of building setback area on Lot 5, Block 1, McEwen 2nd Addition, Wichita, Sedgwick County, Kansas, described as commencing at the southwest corner of said Lot 5; thence north, along the west line of said Lot 5, 30.41 feet more or less to the intersection of the 30 foot building setback line; thence easterly, along said building setback line (being a curve to the right, having a radius of 309.73 feet), 10.1 feet to a point 10 feet east of the west line of said Lot 5, for a place of beginning; thence continuing easterly, along said building setback line and said curve, 26.60 feet to a point 36.5 feet east of the west line of said Lot 5; thence south, parallel with the west line of said Lot 5, 15.97 feet; thence west, at right angles, 26.5 feet; thence north, at right angles, 13.82 feet to the place of beginning.

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

1. That due and legal notice has been given by publication as required by law, by publication in the Daily Record of notice of this vacation proceeding for consecutive weeks on SEP 19 1990 SEP 26 1990
2. No private rights will be injured or endangered by the vacation of the above-described platted building setback, and the public will suffer no loss or inconvenience thereby.
3. In justice to the petitioner(s), the prayer of the petition ought to be granted.

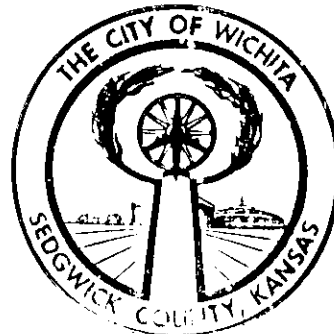
