SETBACKS LOCATED IN THE INDUSTRIAL ADDITION, IN THE
NORTHWEST CORNER OF NORTHERN STREET AND MADISON AVENUE
(District #3)

Staff Recommendation: Approve vacation of building setbacks.

MAPC Recommendation: Approve vacation of building setbacks.
(unanimous)

Background: the applicant seeks a vacation along both Northern and Madison Streets from the platted building setbacks of 60 feet to 15 feet to allow for building expansion along a portion of Northern. At a later time, expansion is expected along Madison, as well. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Action: Close public hearing, approve vacation; authorize the Mayor to sign the Vacation Order; and record certified copy of Order, recording costs to be billed to:

granting the same, makes the following findings:

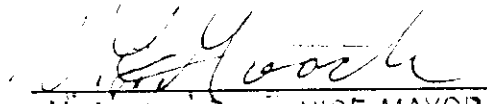
1. That due and legal notice has been given by publication

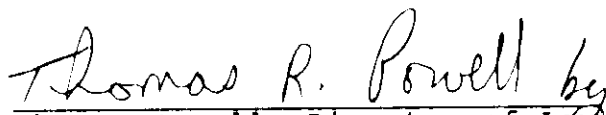

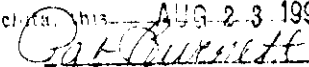
