EASEMENT LOCATED IN AN AREA WEST OF MAIZE ROAD, AND NORTH OF
MAPLE
(District #5)

INITIATED BY: Metropolitan Area Planning Department

AGENDA ACTION: Planning

Staff Recommendation: Approve vacation of platted utility easement.

MAPC Recommendation: Approve vacation of platted utility easement.
(unanimous)

Background: This 10-foot platted utility easement is centered on the common lot line of Lots 5 and 6 and the vacation is being requested in order to realign 3 present lots into 2 building sites. K.G. & E. has an underground electrical line in the easement and has agreed to relocate the line contingent upon a substitute easement being provided. Staff has received the substitute easement. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Action: Accept easement, close public hearing, approve vacation; authorize the Mayor to sign the Vacation Order; and record certified copy of Order and utility easement, recording costs to be billed to:

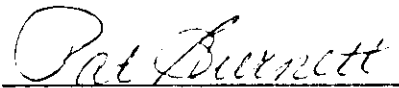

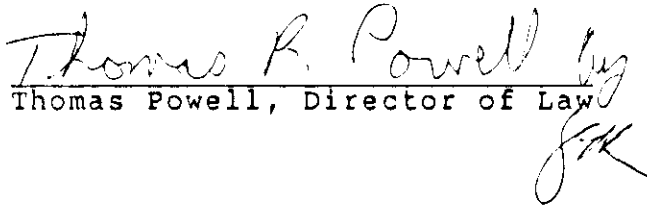
