Background: This 20 foot wide utility easement is located north of Rent-A-Center off of Comotara Drive and is in the Hi-Tech Industrial Addition. The Vacation is being requested to allow for the construction of a new building. The City Engineers and utility Advisory Committee find this vacation acceptable. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.





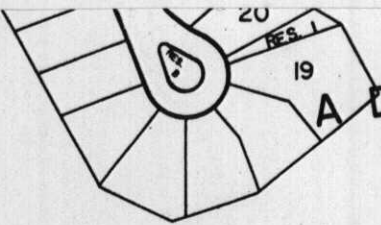
