EASEMENTS LOCATED NORTH OF 31ST STREET SOUTH AND  
EAST OF HILLSIDE. (District 3)

Staff Recommendation: Approve vacation of utility easements.

MAPC Recommendation: Approve vacation of utility easements.  
(Unanimous)

Background: The Plainview Community Church is seeking additional area for a planned expansion of church facilities. Because the Church site consists of five adjacent lots, and adequate sewer and access exists for current and proposed uses, additional sewer or utility easements are not required for each lot as was originally platted. The effect of the proposed vacated easements, and the to be recorded Restrictive Covenant, will be to treat the lots as one undivided parcel, thereby preventing the Church from having to replat.

Legal Considerations: The City Clerk needs to certify as to proper notification and filing of written protest.

Recommendations/Action: Close the public hearing; approve the vacation; authorize the Mayor to sign the Vacation Order; and record the certified copy of the Vacation Order and the Restrictive Covenant; recording costs to be billed to:

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

- 1. That due and legal notice has been given by publication as required by law, by publication in the Daily Reporter of notice of this vacation proceeding for consecutive weeks on 2/25/93 & 3/4/93.
2. No private rights will be injured or endangered by the vacation of the above-described utility easements, and the public will suffer no loss or inconvenience thereby.
3. In justice to the petitioner(s), the prayer of the petition ought to be granted.
4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.
5. The vacation of the utility easements described herein should be approved.

IT IS, THEREFORE, BY THE CITY COUNCIL, on this 9th day of March, 1993, ordered that the above-described utility easements are hereby vacated. IT IS FURTHER ORDERED that the City Clerk shall certify a copy of this order to the Register of Deeds of Sedgwick County.

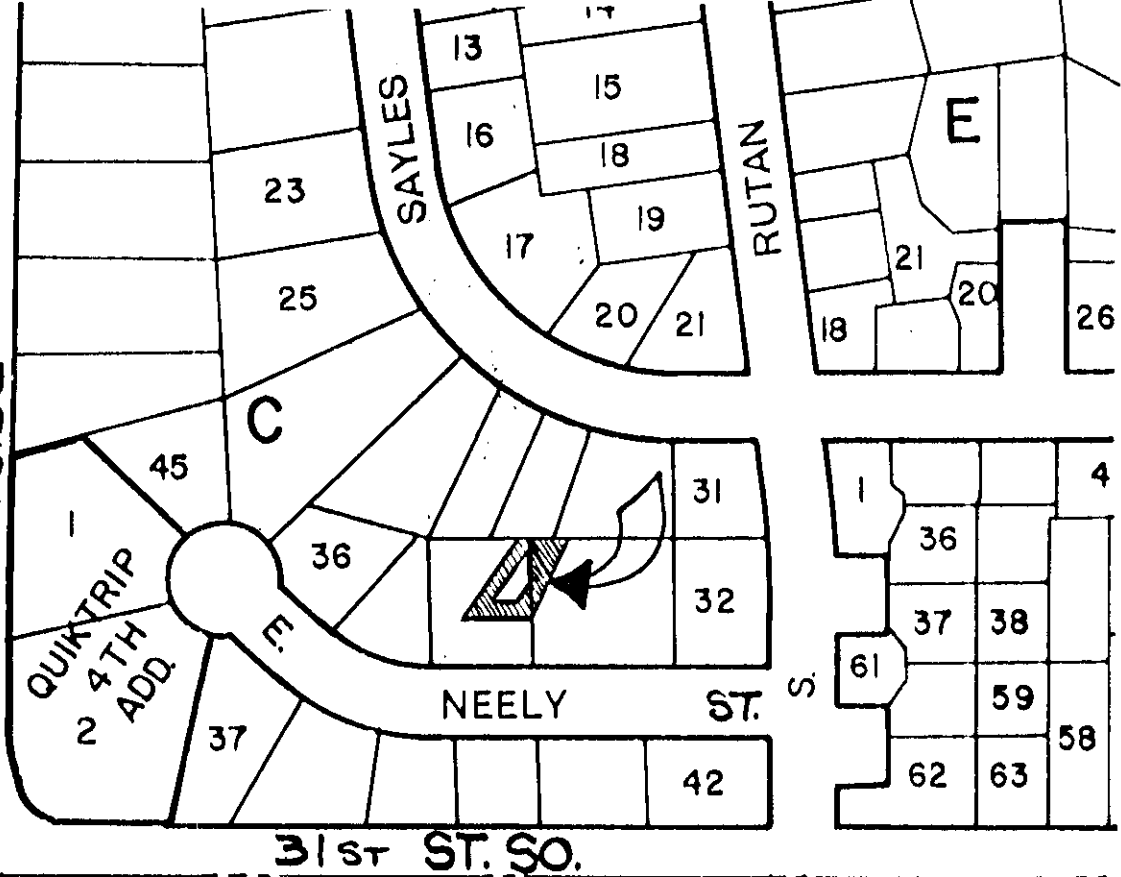
