

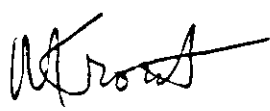

BACKGROUND: A small portion of an attached garage was found to be within the building setback. The vacation is needed to clear the title of the property. City Engineering and the utility representatives of the Subdivision Committee indicate no objections to the vacation. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.
