SUBJECT: PUBLIC HEARING V-1771 REQUEST TO VACATE ROCHESTER AND ASSOCIATED BUILDING SETBACKS FROM 13TH STREET NORTH TO 14TH STREET NORTH IN AN AREA WEST OF WACO
(District #6)

Staff Recommendation: Approve vacation of street right-of-way and building setbacks.

MAPC Recommendation: Approve vacation of street right-of-way and building setbacks. (9-1)

Background: In order to better control traffic and the movements of individuals through the North High School campus area, the School is requesting that the street be vacated so as to change its status from a public facility, to a facility that can then be regulated or controlled by the School. This request was considered at the June 24, 1992 CPO North Central Neighborhood Council 6 meeting and was approved by a vote of 7 to 1. In response to neighborhood concerns, which were expressed both at the CPO and Planning Commission meetings, that neighborhood access not be restricted across this street at non-school periods, the School Board is submitting for the City's acceptance the granting of a public easement for ingress and egress over basically the same area being vacated. This agreement essentially is intended to allow continued public access through this street during those times when the School has no purpose to close the street, while placing maintenance and other related responsibilities on the use of the street (easement) with the School Board.

As requested during review of this case, the applicant is dedicating additional street right-of-way for 13th Street North adjacent to North High school and the vacated right-of-way is being retained as a utility easement. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Attached for the City Council's information is a copy of the July 2, 1992 minutes of the MAPC meeting at which this vacation request was considered. Also, attached is a copy of the easement and right-of-way agreement proposal submitted by the School Board.

VACATION ORDER

NOW on this 20th day of October, 1992, comes on for hearing the petition for vacation filed by Marc Webb for Unified School District #259, praying for the vacation of the following described street right-of-way and building setbacks, to-wit:

Rochester Street from 50 feet north of the center line of 13th Street North to the south right-of-way line of 14th Street North (Avenue D) or as presently exists adjacent to the west line of Lot 1, Dillon 9th Addition to Wichita, Kansas, and Lot 1 on 13th Street, Sherwood's Addition, Wichita, Kansas; together with the adjacent platted building setbacks.

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

1. That due and legal notice has been given by publication as required by law, by publication in the Daily Reporter of notice of this vacation proceeding for consecutive weeks on 10/2/92 & 10/9/92.
2. No private rights will be injured or endangered by the vacation of the above-described street right-of-way and building setbacks, and the public will suffer no loss or inconvenience thereby.
3. In justice to the petitioner(s), the prayer of the petition ought to be granted.
4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.
5. The above indicated right-of-way shall be retained as a utility easement.
6. The vacation of the street right-of-way and building setbacks described herein should be approved.
