Background: Wesley is in the process of making a number of improvements to the Hospital and in particular for its emergency services and access to this facility from Hillside. The vacation has been requested to allow for the improvements needed for the emergency room expansion and entrance changes. City and Traffic Engineering have reviewed this vacation and have indicated no objections. The Subdivision and Utility Advisory Committee have also supported the vacation.

The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

VACATION ORDER

NOW on this 2nd day of June, 1992, comes on for hearing the petition for vacation filed by HCA Health Services of Kansas, Inc., d/b/a Wesley Medical Center, praying for the vacation of the following described building setback, to-wit:

A tract of land lying in Wesley Medical Center Addition, an addition to Wichita, Sedgwick County, Kansas, more particularly described as follows: Commencing at a point lying 20 feet North and 20 feet East of the South and West line of Lot 1, of said WESLEY MEDICAL CENTER ADDITION; thence North 190.00 feet parallel with the said West line to a point of beginning; thence West 20.00 feet; thence North, 50.00 feet; thence East, 15.00 feet; thence North, 80.00 feet; thence East, 5.00 feet, to a point lying 20.00 feet East of said West line; thence South, 130.00 feet parallel with said West line to the point of beginning.

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

1. That due and legal notice has been given by publication as required by law, by publication in the Daily Reporter of notice of this vacation proceeding for consecutive weeks on 5/19 + 5/26/92.
2. No private rights will be injured or endangered by the vacation of the above-described building setback, and the public will suffer no loss or inconvenience thereby.
3. In justice to the petitioner(s), the prayer of the petition ought to be granted.
4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.
5. The vacation of the building setback described herein should be approved.

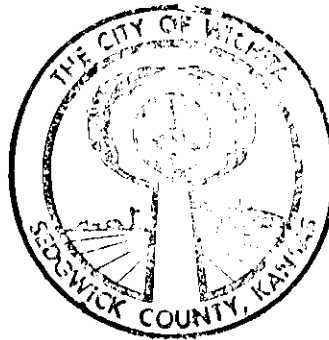

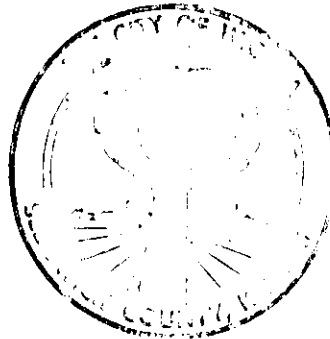
