Both City Engineering and the utility representatives of the Subdivision and Utility Advisory Committee indicate that the easement is not needed. That part of the sanitary sewer easement, exhibit "C" (Line No. 3), as recorded on Film 1093, Pages 1088 and 1091 within the west 440 feet of Lot 2, Block 1, Fairfield Estates, Wichita, Sedgwick County, Kansas. More specifically described as, a 15-foot sanitary sewer easement 7.50 feet on either side of the following described line: Beginning at a point in the north line and 33.67 feet east of the northwest corner of Lot 2, Block 1, Fairfield Estates, Wichita, Sedgwick County, Kansas; said north line having a bearing of S89°33'53"E; thence bearing S51°31'24"W a distance of 374.29 feet; thence bearing N68°03'38"W a distance of 84.27 feet; thence bearing N42°12'03"W a distance of 99.63 feet to the point of ending.

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

1. That due and legal notice has been given by publication as required by law, by publication in the Daily Reporter of notice of this vacation proceeding for consecutive weeks on 3/25/92 & 4/1/92.
2. No private rights will be injured or endangered by the vacation of the above-described sanitary sewer easement, and the public will suffer no loss or inconvenience thereby.
3. In justice to the petitioner(s), the prayer of the petition ought to be granted.

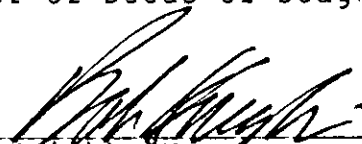

5. The vacation of the sanitary sewer easement described herein should be approved.

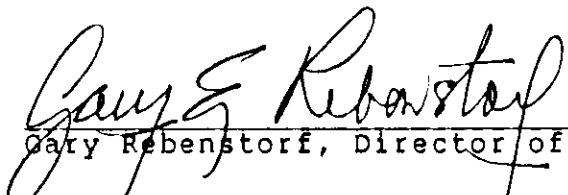

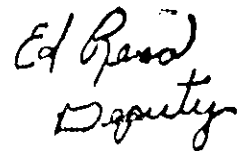

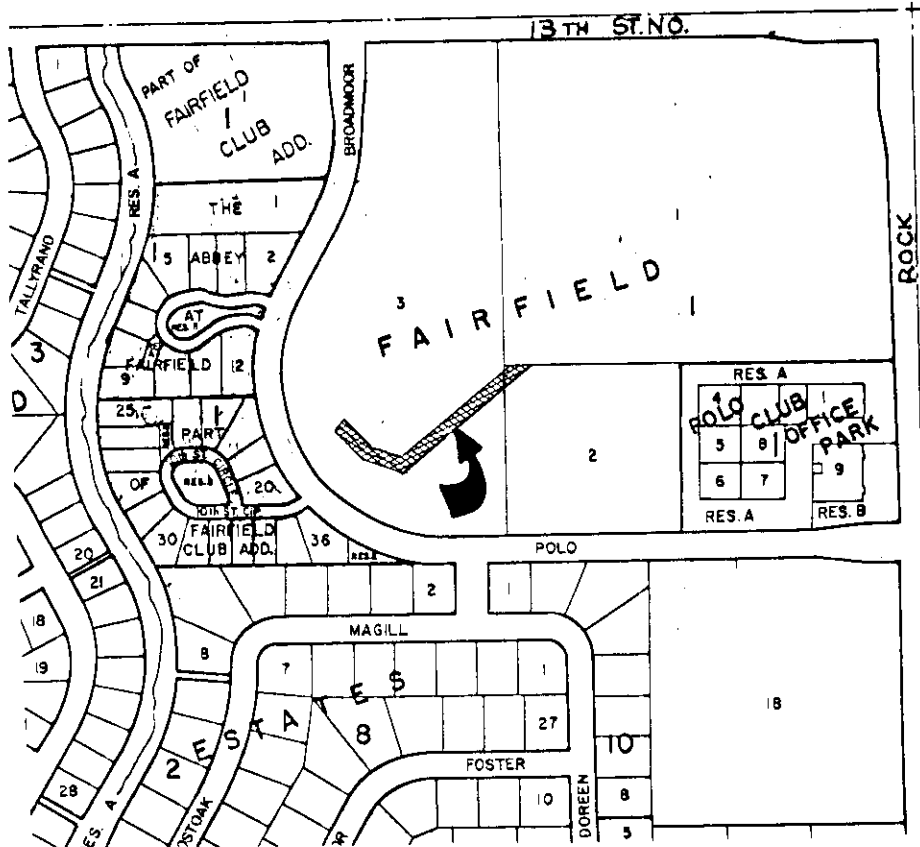
