Staff Recommendation: Approve vacation of sanitary sewer easements.

MAPC Recommendation: Approve vacation of sanitary sewer easements.
(unanimous)

Background: While when platted, these sanitary sewer easements were provided for the extension of sewer, the actual extension of sewer to the adjoining lots has been by means of other easements. City Engineering has confirmed that these easements are no longer needed for sanitary sewer. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

VACATION ORDER

NOW on this 19th day of May 1992, comes on for hearing the petition for vacation filed by Earl M. Sayler, praying for the vacation of the following described sanitary sewer easements, to-wit:

The 20-foot sanitary sewer easement over the west 20 feet of Lot 1, EXCEPT the north 10 feet thereof, Sayler Addition, Wichita, Sedgwick County, Kansas.

The 8-foot sanitary sewer easement over the east 8 feet of Lot 6, EXCEPT the south 10 feet and the northerly 20 feet thereof, Sayler Addition, Wichita, Sedgwick County, Kansas.

The 12-foot sanitary sewer easement over the west 12 feet of Lot 7, which extends northerly through said Lot 7 and intersects with a 20-foot utility easement granted adjoining Evergreen Court, EXCEPT the south 10 feet thereof and EXCEPT the 20 feet adjoining Evergreen Court, Sayler Addition, Wichita, Sedgwick County, Kansas.

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

1. That due and legal notice has been given by publication as required by law, by publication in the Daily Reporter of notice of this vacation proceeding for consecutive weeks on MAY 4 1992-MAY 11 1992

2. No private rights will be injured or endangered by the vacation of the above-described sanitary sewer easements, and the public will suffer no loss or inconvenience thereby.

3. In justice to the petitioner(s), the prayer of the petition ought to be granted.

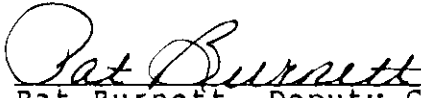
4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.
