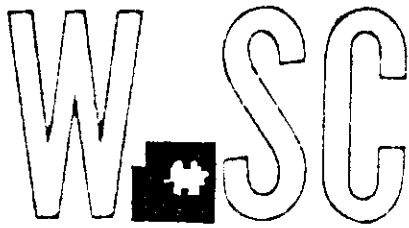

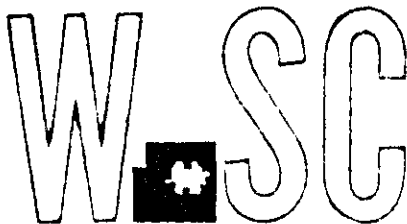

At the regular meeting of the Subdivision Committee of the Metropolitan Area Planning Commission, Thursday, March 5, 1992, the above-captioned vacation request was considered. The action of the Committee was to recommend that this vacation be approved subject to:

- A. Any relocation or reconstruction of utilities necessitated by this vacation shall be at the sole expense of the applicant.
- B. As requested by City Engineering, the legal description shall be amended to exclude out the north 10 feet thereof.
- C. As indicated by K.G. & E., their utilities and several others, are apparently located within this easement. All such utilities will need to be relocated for this easement to be vacated. The applicant shall submit from each utility (K.G. & E., S.W. Bell, Cable) a letter indicating that arrangements have been made for any such relocations or that the utility has no improvements within this easement. These letters must be submitted prior to this case being scheduled for City Council review.

LEGAL DESCRIPTION: The 10 foot utility easement as platted along the west line of Lot 21, Block 3, Willowbend First Addition to Wichita, Sedgwick County, Kansas, except for the north 10 feet thereof.

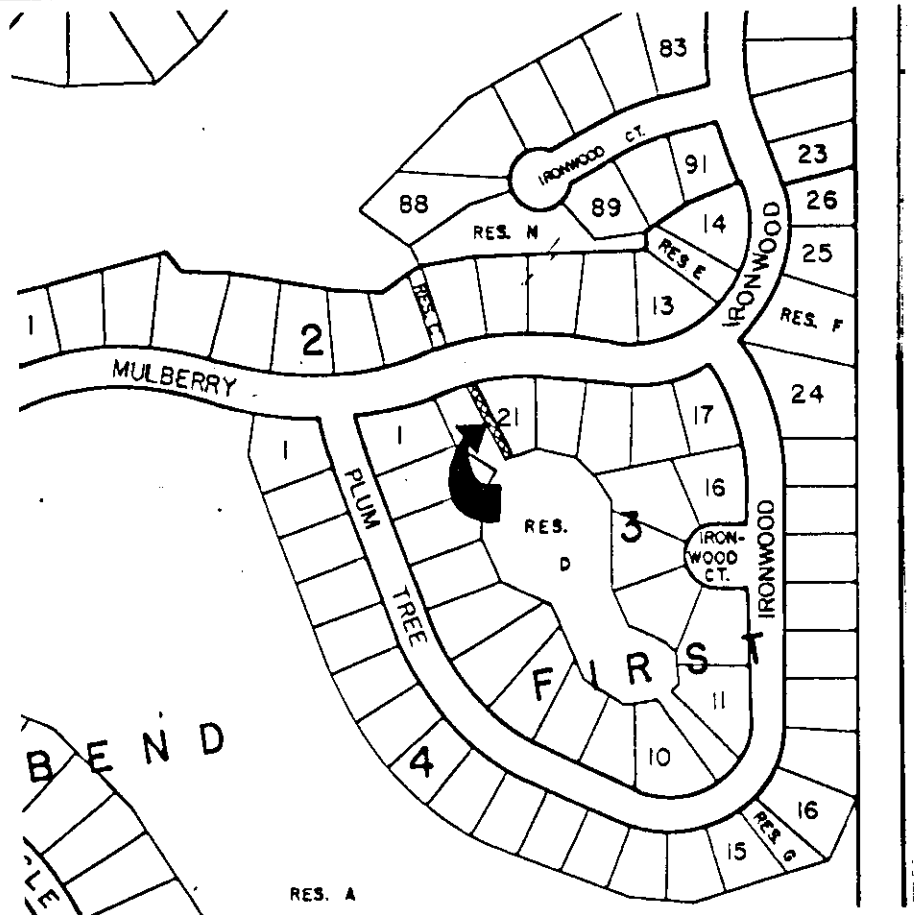
LOCATION: East of Rock Road and north of 37th St. North.
