



Background: The applicant is requesting additional access for a diagnostic center and parking garage presently under construction. Santa Fe is a one way street south and carries low to moderate traffic volumes. Traffic Engineering and the Subdivision Committee have indicated that the vacation should have no adverse effects. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Action: Close public hearing, approve vacation; authorize the Mayor to sign the Vacation Order; and record certified copy of Order, recording costs to be billed to:

4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.
5. The vacation of the access control described herein should be approved.
