Staff Recommendation: Approve vacation of building setback.

MAPC Recommendation: Approve vacation of building setback. (unanimous)

Background: The building setback involved in this vacation was originally platted to an adjacent public street. That street was, however, vacated a number of years ago. The building setback, though, was not vacated at that time. The applicant is now planning an addition to an existing house, that would encroach this building setback. Since a public street is no longer involved, the Subdivision Committee has agreed that the previously platted setback is unnecessary and the portion requested for vacation is acceptable. City Engineering and the utilities have also noted that no utilities will be impacted by the vacation. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Actions:

Close the public hearing, approve the vacation;
authorize the Mayor to sign the Vacation Order; and
record the certified copy of the Vacation Order;
