SUBJECT: V- 1833; Request to vacate utility easement, generally located east of Rock and south of 37th Street North. (District # 2).

INITIATED BY: Metropolitan Area Planning Department



AGENDA ACTION: Planning

Staff Recommendation: Approve vacation.

MAPC Recommendation: Approve vacation (unanimous).

Background: This is the vacation of utility easements granted by separate instrument rather than being platted. The easements were utilized for the provision of a water line to serve this single, large lot. This case will permit applicant to abandon a portion of the existing easement and waterline, with the effect of shortening the distance from the new structure to the water main. Staff and MAPC have recommended approval because availability of water to this site should be unaffected, and the vacation will not adversely affect the public interest.

This vacation has been reviewed and approved by the Planning Commission, subject to conditions and recording within 30 days.

RECOMMENDATIONS/ACTIONS: Close the public hearing; approve the vacation; authorize the Mayor to sign the Vacation Order; and record the certified copy of the Order; recording costs to be billed to:

5. The vacation of the portion of utility easement described herein should be approved.

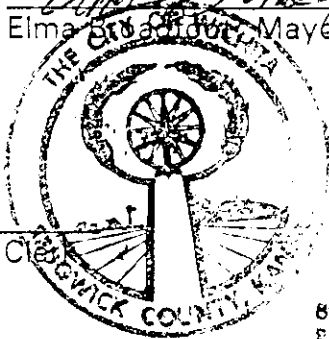

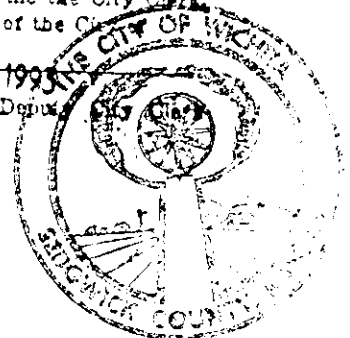


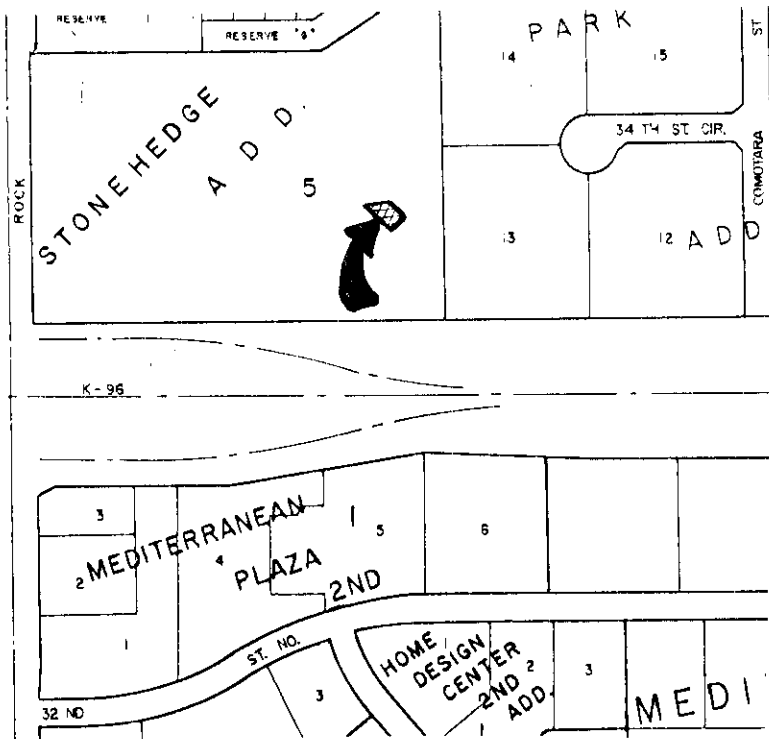
