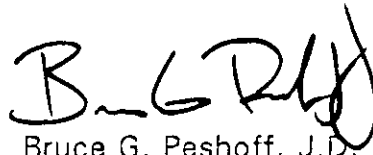
Dear Applicants:

At the regular meeting of the Metropolitan Area Planning Commission, on Thursday, August 12, 1993, the above referenced vacation request was considered. The action of the Planning Commission was to recommend that this vacation be approved, subject to the following conditions:

- A. Any relocation or reconstruction of utilities necessitated by this vacation shall be the sole responsibility and expense of the applicants.
- B. Applicant shall dedicate, by separate instrument, a 10-foot public utility easement along the east boundary (i.e. - the park/reserve centerline) of applicant's ownership.
- C. Based upon information from representatives from the utility companies regarding regulatory information, applicant is hereby notified that "open supply conductors and service cables shall not pass over a swimming pool, ... or within 10 feet of the edge of the pool, ... diving platform, [or] observation stands." As noted in *Staff Comment A*, any relocation or reconstruction of utilities necessitated by this vacation **due to the location of utility lines (KG&E, Multimedia) over or within 10 feet of the swimming pool and/or deck** shall be the sole responsibility and expense of the applicants.

Upon satisfactory completion of these conditions, as required by the Metropolitan Area Planning Commission, this case will be scheduled for final public hearing before the Wichita City Council. Should you have any questions regarding this vacation case, please feel free to contact me at 268-4495.

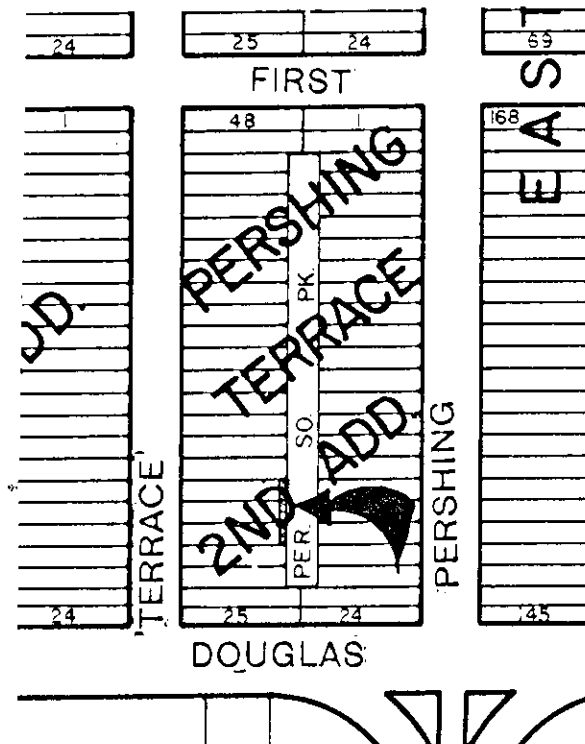
LOCATION: north of Douglas; west of Oliver

However, prior to this application being filed, the reserve apparently was conveyed to all abutting property owners. Sanitary sewer is located along the centerline of the park/reserve area.

STAFF COMMENTS: Approve the vacation subject to the following conditions:

- (A) Any relocation or reconstruction of utilities necessitated by this vacation shall be the sole responsibility and expense of the applicants.
- (B) Applicant shall dedicate, by separate instrument, a 10-foot public utility easement along the east boundary (i.e. - the park/reserve centerline) of applicant's ownership.
- (C) City Engineering should be prepared to discuss and comment upon the acceptability of this vacation, and indicate any conditions and guarantees they may require of the applicants.
