SUBJECT: V- 1826; Request to vacate building setback, generally located south of Mt. Vernon and west of Webb. (District # 2).

INITIATED BY: Metropolitan Area Planning Department



AGENDA ACTION: Planning

Staff Recommendation: Approve vacation.

MAPC Recommendation: Approve vacation (unanimous).

Background: This is the vacation of a portion of a platted 25-foot front yard building setback. A portion of the house was constructed within the building setback area. The present vacation request only applies to that portion of building setback adjacent to and in front of applicant's house. Staff and MAPC have recommended approval because there are no utilities within the setback being vacated, the remainder of front yard building setback is unaffected by this vacation, and the vacation will not adversely affect the public interest.

This vacation has been reviewed and approved by the Planning Commission, subject to conditions and recording within 30 days.

RECOMMENDATIONS/ACTIONS:

Close the public hearing; approve the vacation; authorize the Mayor to sign the Vacation Order; and record the certified copy of the Order, recording costs to be billed to:

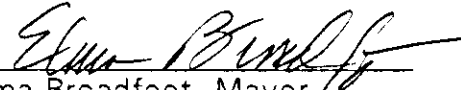

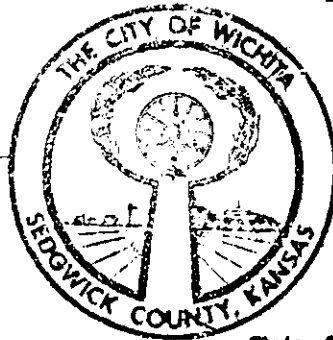
5. The vacation of the portion of building setback described herein should be approved.
