SUBJECT: V- 1825; Request to vacate right-of-way, generally located north of Harry and east of Washington. (District # 7).

Staff Recommendation: Approve vacation.

MAPC Recommendation: Approve vacation (unanimous).

Background: This is the vacation of a portion of an alley right-of-way. Applicant operates a taco shop at the northeast corner of Washington and Harry. Land south of the alley proposed to be vacated is where the building is located, land north of the alley is used for parking. This vacation will permit applicant to pave the alley right-of-way area, and fence together the adjoining properties for improved security. Staff and MAPC have recommended approval because the alley has very limited use and is unpaved, additional right-of-way is being dedicated for Harry and Washington, the vacated right-of-way will be retained as public utility easement, and the vacation will not adversely affect the public interest.

This vacation has been reviewed and approved by the Planning Commission, subject to conditions and recording within 30 days.

RECOMMENDATIONS/ACTIONS: Close the public hearing; accept the dedications; approve the vacation; authorize the Mayor to sign the Vacation Order; and record the certified copy of the Order and the dedications, recording costs to be billed to:

3. In justice to the petitioner(s), the prayer of the petition ought to be granted.
4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.

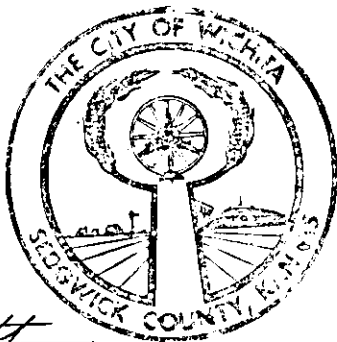

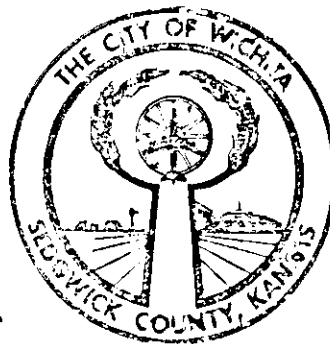
