**Staff Recommendation:** Approve vacation.

**MAPC Recommendation:** Approve vacation (unanimous).

**Background:** This is the vacation of a utility easement. This lot was platted with a blanket utility easement in the rear yard, as were adjacent lots. A similar vacation request was approved for the adjacent lot to the north. Applicant has requested the vacation of that portion of utility easement not being utilized by the City or utility companies in order to build a detached garage for his single-family house. Staff and MAPC have recommended approval because, upon examination by Staff and utility company representatives, reducing the blanket easement in width would provide applicant with sufficient area to build the garage, and would still provide existing and anticipated utilities with sufficient protections.

This vacation has been reviewed and approved by the Planning Commission, subject to conditions and recording within 30 days.

**RECOMMENDATIONS/ACTIONS:** Close the public hearing, approve the vacation; authorize the Mayor to sign the Vacation Order; record the certified copy of the Order, recording costs to be billed to:

That portion of platted utility easement described as: The utility easement on Lot 20, Block 2, Classen Parked Addition, Wichita, Kansas, except that part of said Lot 20 described as being a 20' wide strip of land lying easterly of, parallel to and adjoining a line beginning at a point on the northerly line of said Lot 99.5 feet easterly of the NW corner of said lot and extending to a point southerly line of said lot 96.5 feet easterly of the SW corner of said lot, and also except that part of said Lot 20 described as being located northeasterly of a line beginning at a point on the northerly line of said Lot 189.0 feet easterly of the NW corner of said lot and extending to a point on the southerly line of said Lot 206.0 feet easterly of the SW corner of said lot.

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

- 1. That due and legal notice has been given by publication as required by law, by publication in the Daily Reporter of notice of this vacation proceeding for consecutive weeks on 5/14/93 & 5/21/93.
2. No private rights will be injured or endangered by the vacation of the above-described utility easement, and the public will suffer no loss or inconvenience thereby.
3. In justice to the petitioner(s), the prayer of the petition ought to be granted.
4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.
5. The vacation of the utility easement described herein should be approved.

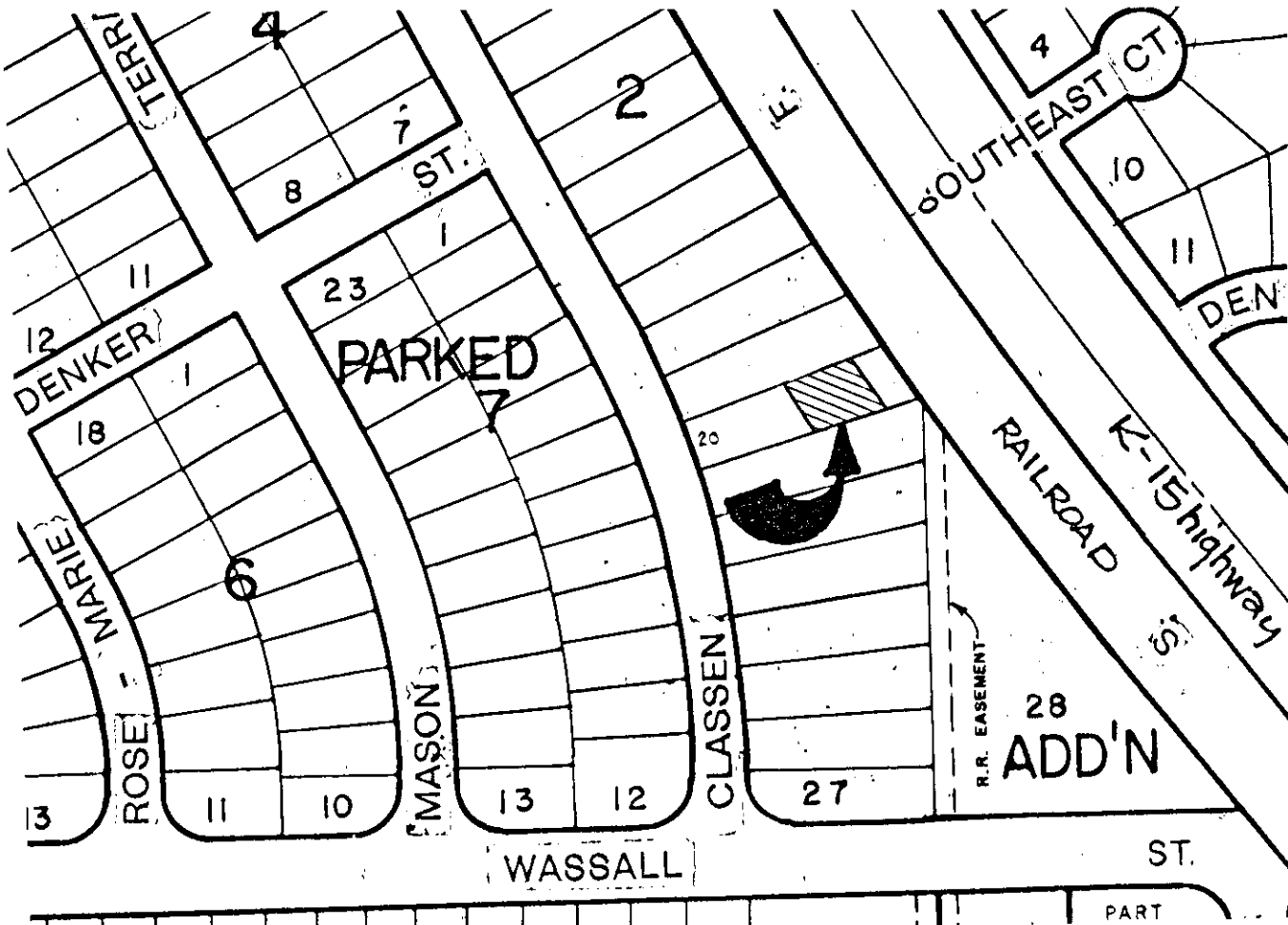
