SUBJECT: V- 1803; Request to vacate portions of utility easement and building setback, generally located south of Harry and west of Webb.
(District #2).

Staff Recommendation: Approve vacation.

MAPC Recommendation: Approve vacation (unanimous).

Background: This is the vacation of portions of pipeline utility easement, and building setback from that easement. Area at one time reserved for pipeline easement through these six lots is no longer necessary. The vacation of easement will increase the amount of buildable space for single-family houses fronting along Stacey. Staff and MAPC have recommended approval because pipeline is not located in the this easement, and as such, related building setbacks are not needed, nor will their vacation adversely affect the public interest.

This vacation has been reviewed and approved by the Planning Commission, subject to conditions and recording within 30 days.

RECOMMENDATIONS/ACTIONS:

Close the public hearing; accept the Easements; approve the vacation; authorize the Mayor to sign the Vacation Order; and record the Easements and certified copy of the Order, recording costs to be billed to:

The west 20.4 feet of the east 43.4 feet of Lots 1 thru 5, inclusive, Block 4, Fourth Addition to Cedar Ridge, Wichita, Kansas, except the north 15 feet of said Lot 1 and the south 15 feet of said Lot 5 thereof.

UTILITY EASEMENT VACATION

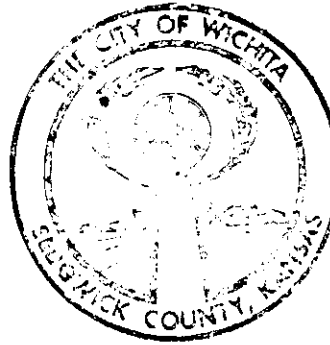

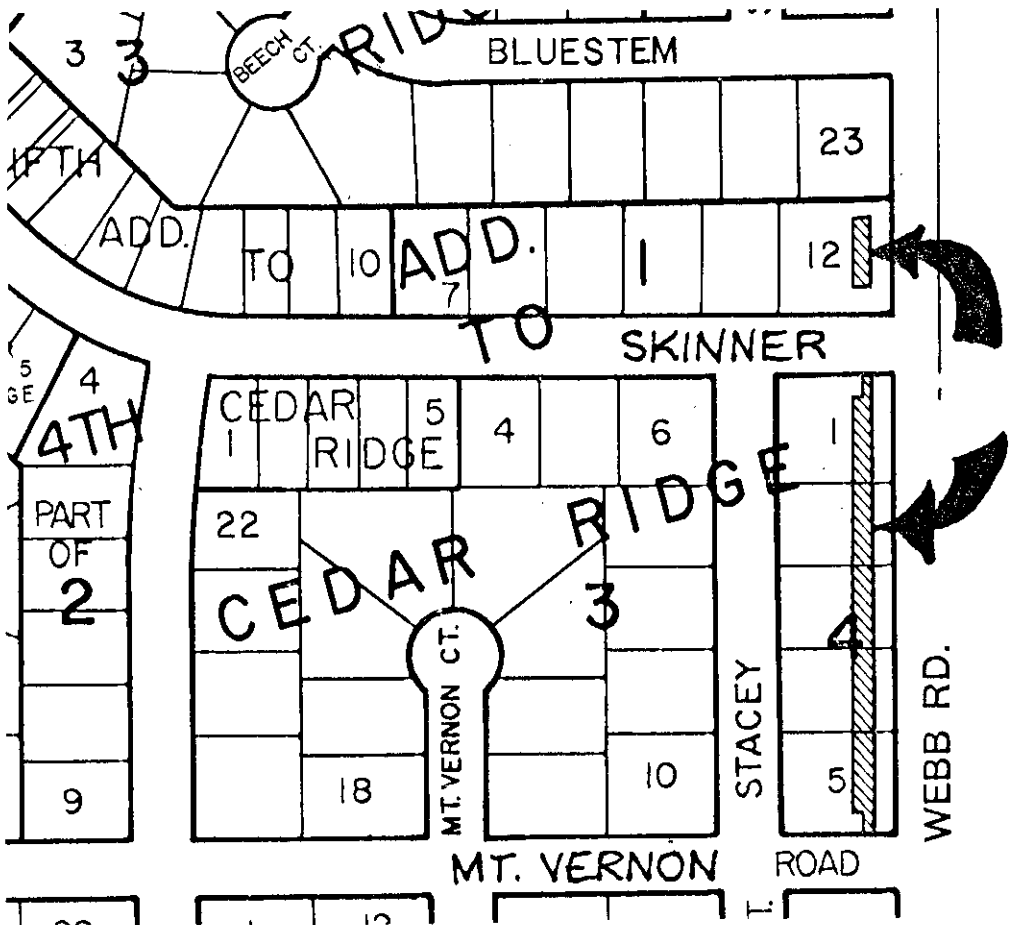
