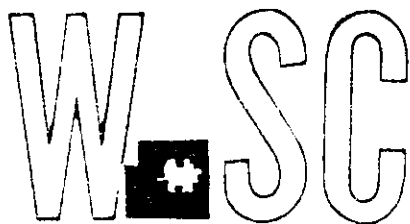

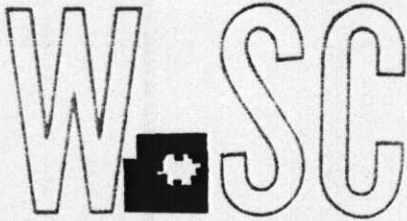

SITE SIZE:

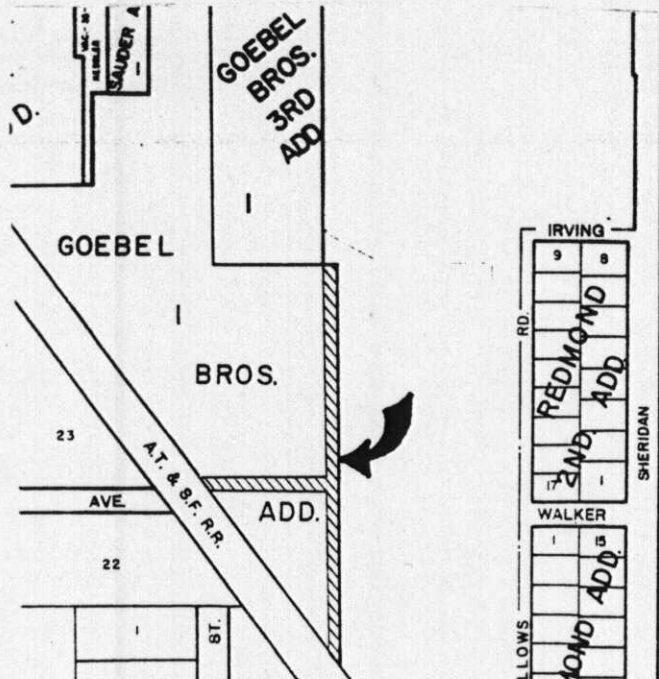
