SUBJECT: PUBLIC HEARING V-1913 REQUEST TO VACATE ACCESS CONTROL
TO 21ST STREET NORTH IN AN AREA EAST OF TYLER.
(District #5)

INITIATED BY: Metropolitan Area Planning Department *M. Kroat*

AGENDA ACTION: Planning

Staff Recommendation: Approve vacation of access control.

MAPC Recommendation: Approve vacation of access control. (11 - 3)

Background: In order to provide a separate entrance for a planned use on a portion of the involved lot, a second opening is being requested to 21st St. North. Presently, only one (1) opening was platted for this site (lot). Planning staff had indicated some concern with this request, but the Traffic Engineering indicated that the additional opening should not be a detriment. At the immediate intersection of 21st and Tyler Streets, the applicant expanded the area protected by complete access controls, and the applicant has submitted appropriate dedications. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions. In their motion, the Planning Commission also recommended that left turns not be permitted from the proposed opening; however, in subsequent discussion with the Traffic Engineer, he indicated that this restriction was not necessary.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Actions: Accept the dedications of access control; close the public hearing; approve the vacation; authorize the Mayor to sign the Vacation Order; and record a certified copy of the Vacation Order and the dedications; recording costs to be billed to:

5. That access control shall be retained except for two (2) openings.
6. The vacation of the access control described herein should be approved.




