Staff Recommendation: Approve vacation of utility easement.

Background: This site is in the County within Arbor Lakes Estates. The applicant owns both lots and is requesting vacation of a common lot line utility easement to permit construction of a house across the common lot line. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: This request for vacation is located on property outside the City of Wichita, but within three miles thereof. As such, no petition, publication of notification or public hearing is required before the Wichita City Council.

Recommendations/Action: Approve vacation.

VACATION ORDER

NOW on this 19th day of October, 1994, at 9:00 o'clock A.M. comes on for hearing a petition praying for the vacation of the following-described real property, to wit:

The 10-foot utility easement platted along the common lot line of Lots 9 and 10, Block 1, Arbor Lakes Estates to Sedgwick County, Kansas, except the north 20 feet of the west 20 feet thereof.

WHEREUPON, it is shown that proper notice has been given by publication once each week for three consecutive weeks in the official county paper, the first such publication having occurred on September 30, 1994, and it is further shown that proper proof of such publication has been filed herein. The Board finds that such notice is in lawful form and that it conforms to K.S.A. 58-2613.

THEREAFTER, the Board, having heard all interested parties and being otherwise duly advised in the premises, finds and determines that no private rights will be injured or endangered by such vacation; that the public will suffer no loss or inconvenience thereby; that no written objections hereto have been filed with the Sedgwick County Clerk; and that, in justice to the petitioner, the petition's prayer should be granted.

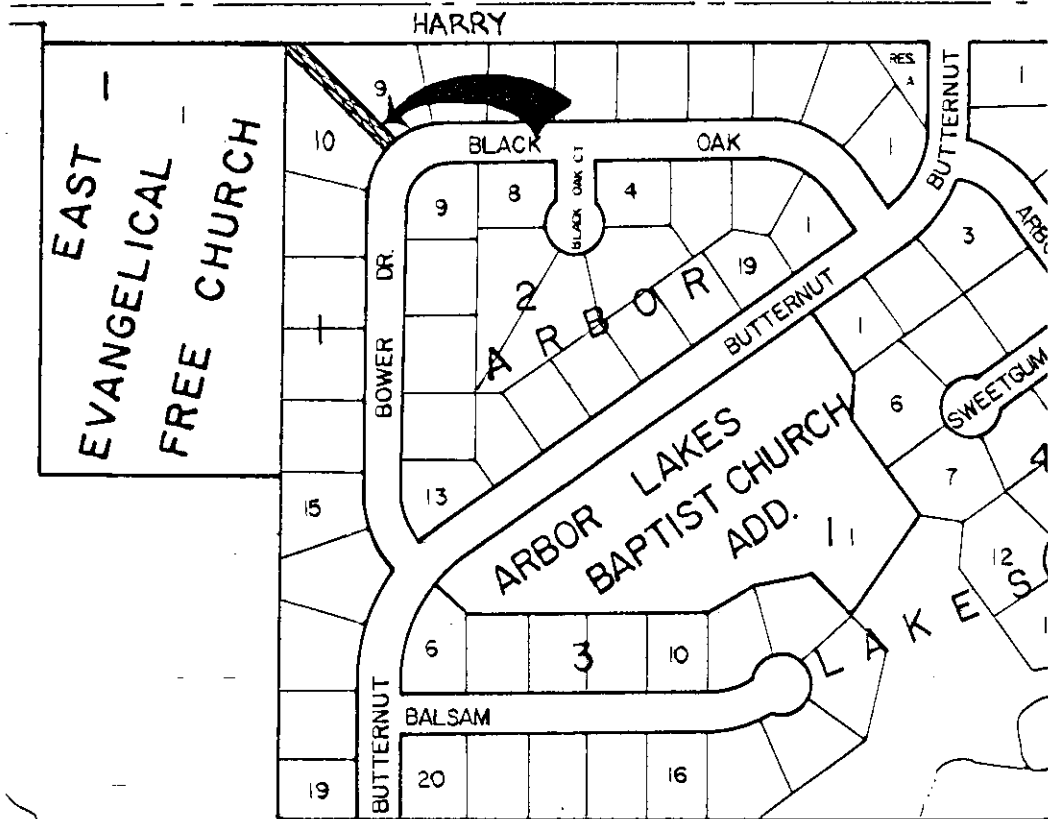
