SUBJECT: PUBLIC HEARING V-1864 Request to vacate a portion of utility easement located north of 13th St. N. and east of 119th St. West. (District #5)

INITIATED BY: Metropolitan Area Planning Department



AGENDA ACTION: Planning

Staff Recommendation: Approve vacation of utility easement.

MAPC Recommendation: Approve vacation of utility easement. (unanimous)

Background: An existing home was found to be encroaching the easement and the vacation is needed to remove the cloud on the property's title. A City sanitary sewer line is located in the portion of the easement located on the adjacent lot. While City Engineering does not encourage reducing an easement being used for a sewer line, the minor area involved in this vacation case should not create any problems. Other utility representatives of the Subdivision Committee also indicate that none of their facilities would be impacted.

The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Actions: Close the public hearing; approve the vacation; authorize the Mayor to sign the Vacation Order; and record a certified copy of the Vacation Order; recording costs to be billed to:

NOW on this 17th day of May, 1994, comes on for hearing the petition for vacation filed by George Seferoglou, praying for the vacation of the following described utility easement, to-wit:

That part of Lot 12, Block 9, Echo Hills an Addition to Wichita, Sedgwick County, Kansas described as commencing at the S.E. Corner of said Lot 12; thence N 57° 52' 45" W, along the south line of said Lot 12, 69.87 feet; thence N 15° 49' 02" E, 5.77 feet for a place of beginning; thence continuing N 15° 49' 02" E, 4.65 feet to a point on the northerly line of the platted 10 foot utility easement; thence S 57° 52' 45" E, along the northerly line of said easement, 16.57 feet; thence N 74° 10' 58" W, 15.90 feet to the point of beginning.

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.
5. The vacation of the utility easement described herein should be approved.

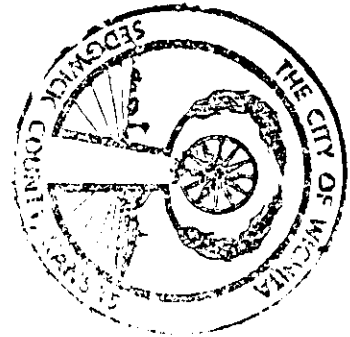
