MAPC Recommendation: Approve, subject to condition. (unanimous)

Staff Recommendation: Approve, subject to condition.

Background/Discussion: The applicant desires to remove 5 feet of a platted 25 foot drainage and utility easement. The easement was provided for in the original development to provide sufficient area for drainage, sanitary sewer, and other utilities. Both County Engineering and the utility representatives of the Subdivision Committee indicate that no facilities are located in the easement and the remaining 20 feet of easement is adequate to serve the area. Therefore, the drainage and utility easement may be vacated so as to allow the applicant to further develop in this area.

The vacation request has been reviewed and approved by the Planning Commission subject to conditions. No members of the public addressed the MAPC in opposition to this request.

Recommended Action: 1. Open public hearing to receive public comments; close public hearing, approve the vacation order and authorize the Chair to sign.

The Board further finds that on 31st day of October, 1996, the Metropolitan Area Planning Commission recommended that the vacation petition herein be approved; and on the 3rd day of December, 1996, the City Council of the City of Wichita recommended that the said petition be approved.

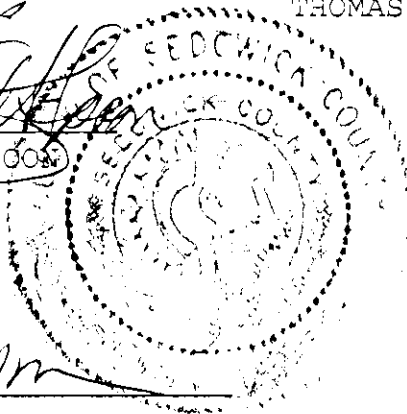
