SUBJECT: PUBLIC HEARING V-2064 REQUEST TO VACATE PLATTED BUILDING SETBACK LOCATED AT THE CORNER OF WEST AND 17TH STREET NORTH.
(District #5)

AGENDA ACTION: Planning

Staff Recommendation: Approve vacation of building setback.

MAPC Recommendation: Approve vacation of building setback. (unanimous)

Background: The applicants are requesting the vacation of a portion of the platted 25-foot building setback along 17th Street just east of West Street, down to 20 feet, in order to construct a detached garage. The contractor applied for a building permit and was advised of the platted building setback restriction.

The Subdivision/Utility Committee recommended the request to vacate a portion of the platted building setback be approved subject to the following conditions:

- A. Any relocation or reconstruction of utilities made necessary by this vacation shall be the responsibility of the applicant.

The MAPC recommended approval of the Subdivision/Utility Committee recommendation. No members of the public spoke in opposition to this request.

Recommendations/Actions:

Close the public hearing, approve the vacation; authorize the Mayor to sign the Vacation Order; record the certified copy of the Vacation Order, recording costs to be billed to:

VACATION ORDER

NOW on this 3rd day of March, 1998, comes on for hearing the petition for vacation filed by Lawrence R. & Shirley A. Ricke, praying for the vacation of the following described building setback, to-wit:

That portion of the platted building setback described as beginning at the SW corner of Lot 20, Block 6, Sunset Heights 3rd Addition to the City of Wichita, Sedgwick County, Kansas; thence north along the west line of said Lot 20 a distance of 25 feet; thence east and parallel to the south line of said Lot 20 a distance of 31.5 feet to the point of beginning; thence east and parallel to the south line of said Lot 20 a distance of 22 feet; thence south and parallel to the east line of said Lot 20 a distance of 5 feet; thence west and parallel to the south line of said Lot 20 a distance of 22 feet; thence north and parallel with the east line of said Lot 20 a distance of 5 feet to the point of beginning.

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

1. That due and legal notice has been given by publication as required by law, by publication in the Daily Reporter of notice of this one time 2-6-98, which was at least 20 days prior to this public hearing.
2. No private rights will be injured or endangered by the vacation of the above-described building setback, and the public will suffer no loss or inconvenience thereby.
3. In justice to the petitioner(s), the prayer of the petition ought to be granted.
4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.
5. The vacation of the building setback described herein should be approved.





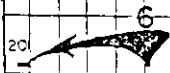
