SUBJECT: PUBLIC HEARING V-2061 REQUEST TO VACATE PORTION OF PLATTED BUILDING SETBACK LOCATED IN AN AREA SOUTHWEST CORNER OF 31ST STREET SOUTH AND HANDLEY AVENUE, EAST OF SENECA AND SOUTH OF 31ST STREET SOUTH.
(District #4)

AGENDA ACTION: Planning

Staff Recommendation: Approve vacation of platted building setback.

MAPC Recommendation: Approve vacation of platted building setback. (unanimous)

Background: This property was recently rezoned to the "NR" Neighborhood Retail zoning district. The applicant proposes to begin construction on the property and wishes to be allowed to use the maximum width of the lot allowed under the "NR" zoning, which is 15-feet for a street side yard. The property was platted with a 30-foot setback along Handley Avenue when it was platted several years ago. The change in zoning and proposed use is the reason behind the request to vacate a portion of the platted building setback.

The Subdivision/Utility Committee recommended the request to vacate a portion of the platted building setback be approved subject to the following conditions:

- A. Any relocation or reconstruction of utilities made necessary by this vacation shall be the responsibility of the applicant.

The MAPC recommended approval of the Subdivision/Utility Committee recommendation. No members of the public spoke in opposition to this request.

Recommendations/Actions: Close the public hearing, approve the vacation; authorize the Mayor to sign the Vacation Order; record the certified copy of the Vacation Order, recording costs to be billed to: 150003-2909




